this twenty-sixth day of November, 1949, do  
**HEREBY ADOPT, ENACT AND GIVE TO  
OURSELVES THIS CONSTITUTION.**

## About the Competition

2<sup>nd</sup> Dr. B.R. Ambedkar Constituent Assembly Debate 2022 seeks to instill the spirit of constitutionalism as a guiding principle for the future generations of the legal fraternity. This competition will hone the skills of the future generation of lawyers and lawmakers who will shape the legal landscape of the country.

The competition will enhance the knowledge and appreciation of constitutional principles, and understanding of the framework of the constitution, and acquaint the law students with the intentions of the constitutional makers and the jurisprudential principles behind the constitutional provisions. This academic endeavour is an attempt to revisit, rethink and rebuild the Constitution of India based on the experience of the past 60 years of Indian democracy.

## Format of the Competition

The competition aims to harness the skills of the future sculptors of the country's legal landscape. The knowledge and appreciation of constitutional principles, understanding of the framework of the constitution, and acquaint the law students with the intentions of the constitutional makers. CAD is an innovative format of the debate that aims at recreating the Constituent Assembly Debates that led to the formation of the Constitution of India - we seek to provide law students with the opportunity to reimagine the Constitution of India.

This debate competition will allow students to indulge in a comparative study of international constitutions and enhance their research and interpretation skills to understand the legislative intent behind various provisions of the Constitution of India. It will also help them bring our constitutional values, principles & jurisprudence to the forefront of legal education.



## General Guidelines

- The setting of the competition will be based on the year 2022, after 73 years of India being a republic, more than 105 constitutional amendments, innumerable interpretations, and jurisprudential evolution. The country, as it stands today, will be represented by elected members in a new constituent assembly and recreate the Constitution of India.
- The students will be provided with the topics of debate at the time of registration. The allotment of representation will be made through a draw of lots before the competition.
- The students must acquaint themselves with the history of the original constituent assembly debate.
- The students may also refer to international constitutions to aid their arguments.
- A thorough understanding of all representatives will be necessary to the participants.
- The representative division will be communicated to the participants before Caste-based registration.
- The participants can refer to judicial precedents, obiter dictum, attorney arguments and even credible literary articles to make their debates - although none will have binding authority over the constituent assembly debate.



## Team Composition

- The team for this competition shall consist of two members. It is mandatory for the members of the team to be enrolled in three years or five years undergraduate program course in Law.
- Each team will represent one of the six representations of this constituent assembly. These representations are as follows:
  - Majority Communities
  - SC/ST/OBC
  - Special States - Jammu Kashmir & North-East
  - Women Community
  - Minority Community
  - LGBTQ Community

## Rounds Details

- The competition shall be held in four rounds. These are:
  - **Preliminary Round:** All the participating teams will compete in this round.
  - **Quarters Round:** The top 24 teams (4 from each community) who qualify from the preliminary round shall compete in this round.
  - **Semi-Final Round:** The top 12 teams (2 from each community) who qualify from the quarters round shall compete in this round.
  - **Final Round:** Ultimately, the top 6 teams (1 from each community) who qualify from the semi-finals round shall compete in this round.
- The discretion to make any amendments and changes in the rules of the competition lies with the organizing committee of the event.



## Registration Process:

The following steps must be adhered to by the registering participants to successfully register themselves for the Competition

- Each team will represent one of the six representations of this constituent assembly. These representations are as follows:
- The registration form is provided on our official website: [www.ledx.law](http://www.ledx.law)
- The registration shall be considered complete only when the 'Registration Fee' has been paid successfully and the registration form is duly filled with all the credentials.
- The participants will receive an official approval mail from the organizing committee within 48 hours of their registration.
- The registration fee for the competition is Rs 400 per team.

- Allocation of Representative Category: 23<sup>rd</sup> November 2022
- Preliminary and Quarter Finals: 26<sup>th</sup> November 2022
- Semi-Finals and Finals: 27<sup>th</sup> November 2022

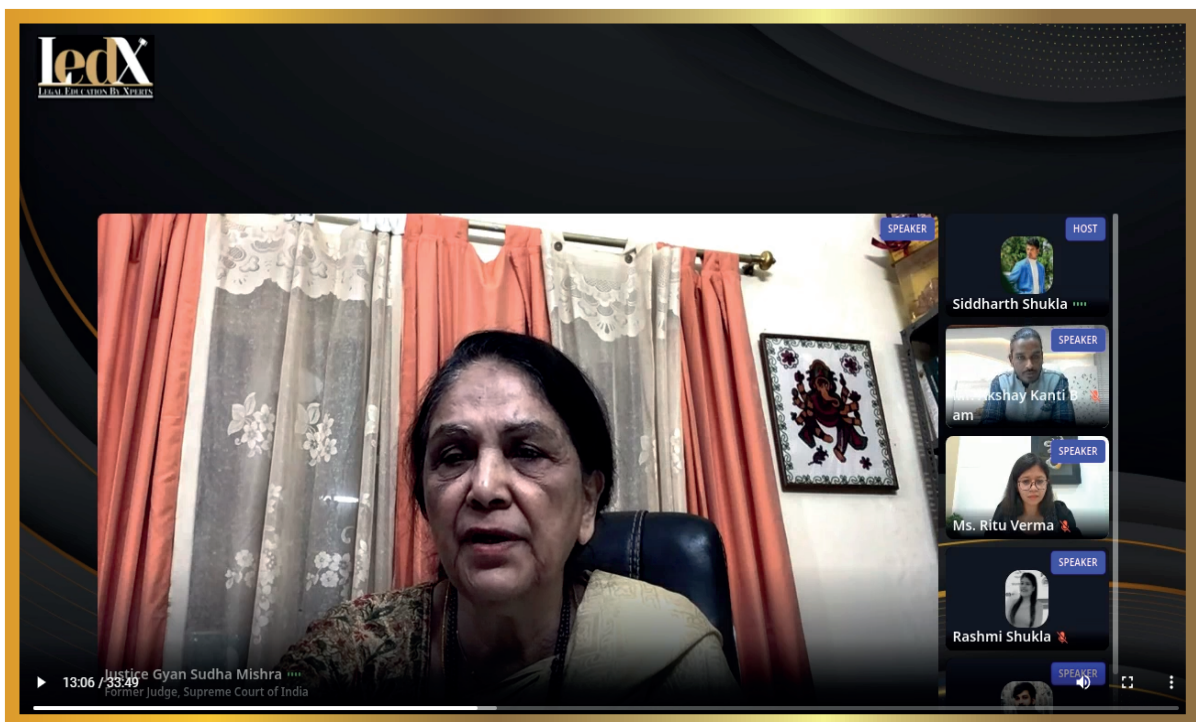
